

Response to queries below:

- where and how the gatepost is to be secured and protected onsite

The gatepost, once removed, won't be stored on site as we want to keep it safe as possible. We are planning to transfer to a pallet on removal and store indoors at Bradwell Sewage Treatment Works (located within the same valley near Hope).

- the mortar mix to be used when the gatepost is reinstalled

No mortar mix will be used on the exterior of the post or adjoining wall. The wall is dry stone and the top cap on the post is loose already. Judging by the fact that the post is already leaning slightly it's probably safe to assume that there is no concrete surround below ground level, so we will aim to re-install in the same way. We do however plan to trial hole around the post prior to removal to ascertain how it is set.
